WARN IF CAN'T CHECK ALERTS AND INTERA	


If you have designated that your patient has a diagnosis that you have added yourself to the Vocabulary System (User-Defined Vocabulary) with its own Meaning (rather than a Synonym of a Program Vocabulary diagnosis) then the program can't check to see if there are any contraindications, warnings, or precautions among the patient's medications and this diagnosis. Prior to version 5.8, the program would not warn you that it could not do an Alert check against this diagnosis. Starting with version 5.8, the program can optionally warn you that this situation has occurred. If you wish to see this warning, check System\Medication Options\Warn if Can't Check Alerts. If you don't like seeing this warning, uncheck this Option.

This same Option also applies if you add a Medication to the Vocabulary System that is not a Synonym of a Program Vocabulary Medication. In this case, the program can't check your Medication for Alerts or for drug Interactions, since these databases are based on terms in

the Program Vocabulary.

Let's see this in action. Suppose you have added a medication called "KINGOPRIL" to the Vocabulary System, defined as a CARDIOACTIVE drug in the KING INHIBITORS Class.

- 1. Check System\Medication Options\Warn if Can't Check Alerts and press OK.
- 2. Press Write\Medications\Add.
- 3. For **Drug**, type in Kingopril and press <Tab>.
- The program notifies you that it can't warn if Kingopril has Interactions and Alerts. (If you don't wish to see this sort of warning, uncheck System\ Medication Options\Warn if Can't Check Alerts and press OK).
- 5. Note that you can still store the drug anyway by pressing **OK**. Do this now.
- 6. Press <ESC> to close the Medication Editor.
- 7. Press Write\Diagnosis for the same patient and press **Add**.
- 8. For **Diagnosis**, enter "hypertension" and press <Tab>.
- The program warns you that it can't check to see if Kingopril is contraindicated in patients with hypertension. (If you don't wish to see this sort of warning, uncheck System\ Medication Options\Warn if Can't Check Alerts and press OK).
- 10. Press **OK** to close this warning. Note that you can still press **OK** to store hypertension as a diagnosis.



RECONCILE YOUR ALLERGIES (User's Manual, pgs. 1098-1099)

You can record each time you verify a patient's list of allergies using Allergy Reconciliation. Let's give it a try: 1. Press Write\Allergies and enter a patient's name.

- Edit the list of Allergies so that it is now accurate and up-to-date.
- 3. Press Utility\ Reconciliation\ Reconcile Now.
- 4. Check each Source that you used in obtaining this information. Patient is checked by default since this will usually be the source of the information, but you might want to check other parties if they have provided you with information about the allergies. If so, give the name of the party or parties in the Name\Description column.
- Check each Method that you used in obtaining the information. Verbal is checked by default since this is the most common method of obtaining the information. If you select Other, type in a description of what method was used.
 Enter an optional Comment

- regarding this verification. For example, if the status of one or more allergies is in doubt, express that doubt as a **Comment**.
- 7. Press **OK** to store this reconciliation information.

Now, let's view previously stored allergy reconciliation information for this patient.

- 1. Inside the Allergy Editor, press Utility\Reconciliation\Log.
- 2. Read the verified list of allergies on a particular date along with the time it was reconciled, the user who did the reconciliation, the **Source**, **Methods**, and **Comment**.
- 3. Press Back to go backward in time and see the previous Allergy Reconciliation (if any).
- 4. Press Next to go forward in time and see the subsequent Allergy Reconciliation (if any).
