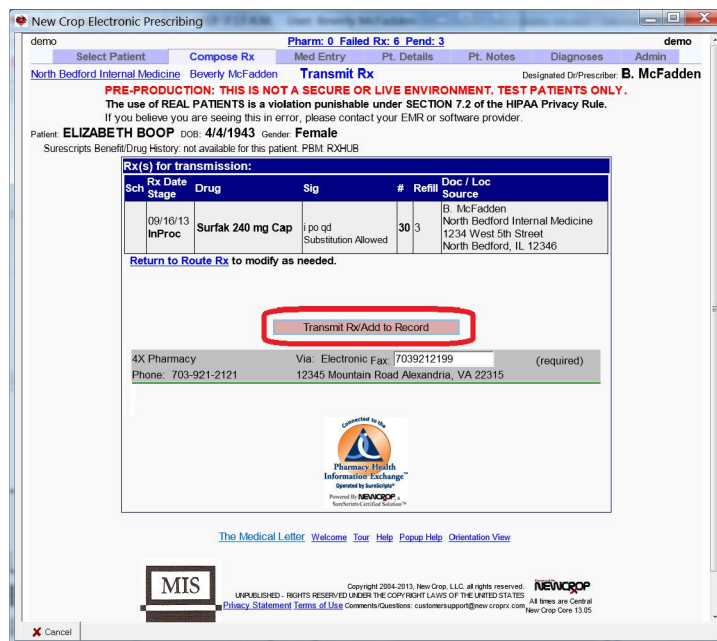

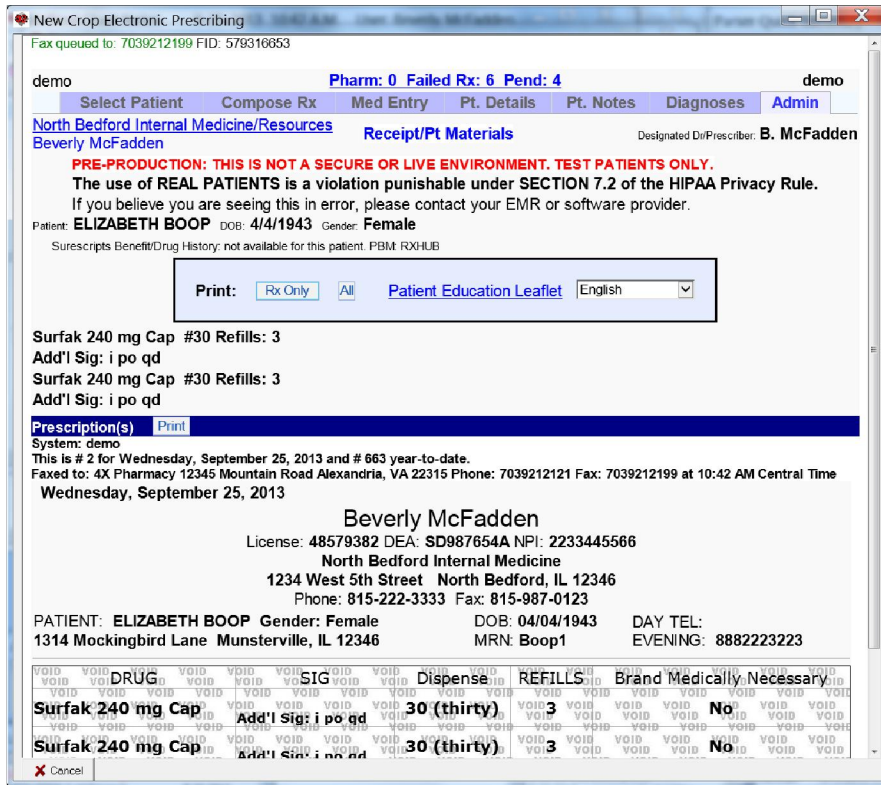
NEW NEWCROP WORKFLOW (User's Manual, pgs. 1060-1061)

When you send a new prescription electronically via NewCrop, there is an additional step in the process on the NewCrop website which has been mandated by SureScripts. (There are no changes when you are responding to a renewal request from a pharmacy). Here are the steps:

1. From the Prescription Log (View\Prescription Log) or the Prescription Writer (Write\Prescriptions), fill in information for the prescription.
2. Press **ERx-NewCrop\Send one** or **Send All**.
3. On the NewCrop **Compose Rx** page, place a checkmark next to each medication you wish to prescribe electronically.
4. Select the name of the patient's pharmacy from the drop-down list at the bottom of the screen.
5. Click the **Instant Renewal** button.



6. This is the new step: you now see a screen which requires you to press the **Transmit Rx/Add to Record** button to send the prescription to the pharmacy. **If you fail to do so, the prescription is NOT sent to the pharmacy.**
7. You can then press <ESC> or **Cancel** to return to **Welford Chart Notes** from the final screen, which looks like this:



- In the event that you have previously started to order a controlled substance which is still listed on the patient's **Compose Rx** page, you might then see a warning that "The account does not have EPCS privileges.", meaning you can't prescribe a controlled substance electronically. In that case, go back to the **Compose Rx** page, click on the "X" to the right of the controlled substance prescription to delete it, then press the **Instant Renewal** button to send the other (non-controlled substance) medication electronically.
